# President's Message

Dear Friends of the East Palo Alto Kids Foundation,

After nine years with EPAK, I am more convinced than ever that providing grants directly to teachers delivers outstanding results in terms of the positive impact made on student learning.

EPAK grants encourage teachers to provide what they know their students absolutely need, often in ways that tap into that teacher's special talents or interests. As an example, a middle school teacher passionate about science, used her grant to purchase microscopes to share the wonders of what cannot be seen by the naked eye while reinforcing the core curriculum. An elementary school teacher who loves acting used her grant to purchase scripts of plays to make reading fluency practice more fun. A teacher's enthusiasm can go a long way to instilling the love of learning in their students. It's a win-win for both teachers and students.

Field trips also bring learning alive. Without EPAK grants, many students would not go on a field trip. And sadly, many children have never been to the beach or a museum. An EPAK grant for up to \$500 covers the cost of transportation for a classroom of students to experience one of our many local treasures. Often teachers will pool their grant monies to take an entire grade to the Tech Museum, the Exploratorium or the tide pools.

This year EPAK funded...

- ➤ 388 classroom micro grants to for a total of \$203,000.
- > 24 classroom start-up grants to **new** district teachers for a total of \$7,000.
- ➤ 3 Sponsored Project grants for a total of \$37,000 for high-impact school programs.

EPAK's busy calendar for the 2010-11 school year included...

- ➤ In the summer, volunteers retrieved valuable classroom materials from East Palo Academy charter (a Stanford New School) from a closed a campus in east Menlo Park. Whole Foods Palo Alto selected EPAK as the beneficiary of its Nickels for Nonprofits program from July September.
- ➤ In August, we provided classroom set-up grants to 24 *new* teachers during a district orientation, made possible by the John & Marcia Goldman

Foundation. Another generous donor funded three weeks of kinder-readiness classes at Brentwood Academy.

- ➤ In September, Borders in Sunnyvale held a book drive and EPAK volunteers managed the distribution of 40 boxes of new books donated by Borders shoppers. The books were valued at \$16,000 and were distributed to Ravenswood schools.
- ➤ In October, we awarded 184 micro grants to classroom teachers.
- In January, we awarded another round of 154 micro grants to classroom teachers. We also distributed 1,250 new books donated by Hoopoe Books in Los Altos to all K-2 classrooms in the district.
- ➤ In March, we solicited applications and made a special one-time grant to educator positions previously not funded, including after-school coordinators, who are helping to expand the school day across the district.
- ➤ In May, we held our annual EPAK Day event at Costano School (K-8) where major donors and volunteers were treated to a program of speakers, student performances and classroom tours led by student leaders.

For sponsored projects this year, two major donors enabled us to continue instrumental music at three of the middle schools, kinder readiness summer classes at Brentwood Academy, and pre-school parent workshops at the Ravenswood Child Development Center.

I'm very proud of what EPAK has accomplished this year and during my two-year tenure as President. It's taken a hard-working board of directors, and many dedicated donors and volunteers to get the work done. We're proud that we've accomplished so much with very low operating costs.

A heartfelt "Thank You" to our supporters who make it possible for EPAK to continue funding quality educational experiences that instill the love of learning in our students.

### Our Mission

The East Palo Alto Kids Foundation (EPAK) is a community-based, volunteer organization whose mission is to promote educational opportunities and academic success for students in East Palo Alto and eastern Menlo Park.

EPAK provides microgrants directly to classroom teachers and matches sponsors to projects that significantly impact the learning environment for more than one classroom of students.

EPAK secures and distributes contributions from individuals, corporations, service organizations, and foundations to help those educating the children in the most direct and immediate way possible. Grant applications for up to \$600 are accepted from classroom and specialist teachers during the Fall and Winter of each school year. New teacher grants are given to teachers before the school year begins to help them start off with the materials that they need.

EPAK manages a Sponsored Projects Grant Program to address needs which impact more than a single classroom of students. EPAK actively identifies needs in the schools, as well as entertains proposals from teachers and principals in the East Palo Alto and East Menlo Park areas. Once a project is approved, EPAK endeavors to match it to a funder.

EPAK is a private, 501(C)3 non-profit Foundation founded in 1993; all donations are tax-deductible. EPAK...

- ✓ Serves approximately 4,500 students PreK-12<sup>th</sup> grade from 11 schools in the East Palo Alto and East Menlo Park areas.
- ✓ Supports quality educational experiences through a variety of grants for literacy, science, math, the arts, and technology.
- ✓ Awards grants to teachers through a selective application process.
- ✓ Is governed by an all-volunteer Board of Directors, comprised of retired and active teachers, administrators, and members of the broader Peninsula community dedicated to providing quality education to all.
- ✓ Addresses the serious educational funding gap that compromises our students' education, and its efforts have direct, tangible, and immediate impact.

### Our Vision

We believe...

#### All children should have an equal opportunity to learn.

Children from low-income families, where English may be a second language and health issues may be left untreated, face challenges that children in higher income, neighboring communities do not. A one-digit difference in ZIP code shouldn't make a difference in the quality of education a child receives. Through our grants, we help bridge the gap between state/local funding and district needs, giving these children greater opportunity to pursue their hopes and dreams.

# A great education can make a difference for our children, our community, and our country.

If we don't provide a quality education to all our children, we are abandoning America's future. Kids who graduate from high school and go on to college will have more opportunities and higher incomes than those who do not. They are less likely to exhibit high-risk behaviors or suffer serious health problems. They will be more prepared for jobs in our global economy and will contribute more to their communities and to the economic health and competitiveness of our country.

#### In a well-rounded education.

Competence in reading, science, math, and the arts, as well as participation in regular physical activity, helps students succeed in school and enrich their lives:

- ✓ Literacy is fundamental, helping children gain general knowledge in all subject areas in school and in adult life.
- ✓ Success in math and science will create opportunities, especially in an increasingly technology-oriented world as represented by Silicon Valley. The country is facing a growing shortage of scientists and engineers—the solution starts in our schools.
- ✓ Study of the arts enhances young people's intellectual, personal, and social development, helping them learn more effectively in other areas of the school curriculum and serving as the basis for creativity and innovation.
- ✓ Investment in PE benefits children physically, mentally, emotionally, and socially. PE classes help prevent and fight childhood obesity and teach healthy habits that can last a lifetime.


#### Teachers know best what is needed in the classroom.

They understand and are committed to the success of their students. By providing grants directly to teachers in the classroom, we are enabling them to address immediate needs. And by investing in our teachers, we show them that the community respects and values them, which can translate into better teacher retention.

# Meeting the Needs in Ravenswood

The needs of Ravenswood's student population present special challenges to its schools. Many students come from challenging family circumstances. Eighty-eight percent of students are eligible to receive Free or Reduced Price Lunch, which means they are socio-economically disadvantaged. In 2009, the median household income in East Palo Alto was \$48,411 compared to \$150,700 in neighboring communities. A majority of parents did not complete high school. Ninety-six percent did not complete college.

A large majority of Ravenswood students are English Language Learners (ELL). This adds to the strain of funding cutbacks. As the mix of cultures, languages, and backgrounds converges in the classroom, educators must find ways to effectively communicate with students. This often involves added costs for listening centers, multi-language textbooks and computer software, or bilingual tutoring. Many ELL students have academic difficulty; unfortunately, their parents often are unable to help them with their homework. The figure below illustrates the ethnic makeup of Ravenswood students.

There is a dramatic and growing educational funding gap between public funds provided to the schools and the resources needed to deliver a quality education. This gap severely undermines the hiring and retention of experienced teachers, causes higher student-to-teacher ratios in the middle grades, and hinders the provision of appropriate classroom resources needed to teach this ethnically diverse, predominantly low-income student population.

Today's reality is that private support is needed to keep schools strong. Schools in wealthier districts raise disproportionately more funds and parent volunteer hours for educational activities. Wealthier districts are able to restore vital programs to schools by raising private funds through educational foundations, PTA fundraising, local bond measures and parcel taxes. There is also the very significant value of parents' donated time in wealthier districts. In a neighboring elementary school, for example, over 33,000 parent volunteer hours are donated each academic year. In the Ravenswood district, where families often juggle low-paying jobs, or lack childcare, volunteering can be difficult.

This results in an achievement gap between wealthy and poor communities. Ravenswood schools are significantly underperforming compared to its wealthier neighbors, as measured by the state's Academic Performance Index (API). Whereas Menlo Park Elementary District and Palo Alto Unified have API scores exceeding 900, Ravenswood has an average API of 715. This is an improvement over the past years, but is still one of the lowest scoring districts in the county. The reality is that a large percentage of Ravenswood students are operating below grade level in Language Arts and Math.

New teachers have very little support or materials for setting up a classroom. Many schools have libraries that fall dramatically below standards, often without librarian support. Field trips occur only if the teacher applies successfully for external monies. Science experiments are uncommon due to a lack of materials. There is little support for typical enrichment activities, such as music and art. Sports equipment and play structures for recess and physical education are in short supply.

# EPAK's Impact - Grants Awarded

In 2010-2011 EPAK awarded \$500 grants to teacher to provide for their students' most critical needs. These contributions improve the quality of the educational experience for these students. In addition these grants show that we support the teachers, who face significant challenges every day, in the important work that they do. Each classroom grant has a direct, immediate, and tangible impact.

During the 2010-2011 school year, the East Palo Alto Kids Foundation awarded...

- ✓ 388 Microgrants totaling \$203,000
- ✓ 24 New Teacher grants totaling \$7000
- ✓ 3 Sponsored projects totaling \$37,000
  - Kindergarten Readiness Program
  - Preschool Parent Workshops
  - Middle School Music Instruction


